Terms & Conditions of Sale

In these Terms and Conditions of Sale, Landmark Ceramics, Inc., is referred to as "Landmark", and the customer or person or entity purchasing Landmark's products (herein referred to as "Products" and "Goods") from Landmark is referred to as the "Buyer".

These Terms and Conditions of Sale, and Landmark's Order Acknowledgement constitute the complete and exclusive agreement and understanding governing the sale of Goods by Landmark to Buyer (the "Agreement") and supersede all prior agreements, understandings or representations, whether written or oral, among the parties with respect to such matters. Provided, however, that if any term, provision or condition of Landmark's Order Acknowledgement should conflict or be inconsistent with any paragraph of these Terms and Conditions, then the content of Landmark's Order Acknowledgement should conflict or achter achter order and control over such conflicting and/or inconsistent terms.

BY ACCEPTING LANDMARK'S ORDER ACKNOWLEDGEMENT AND/OR BY ACCEPTING SHIPMENT OF PRODUCTS, BUYER ACKNOWLEDGES, ACCEPTS, AND AGREES TO THESE TERMS AND CONDITIONS

Landmark reserves, in its sole discretion, the right to refuse any order. No order is accepted by Landmark until: (i) Landmark provides Buyer with a written Order Acknowledgement, and (ii) Buyer duly signs the Order Acknowledgement in acknowledgement, acceptance and agreement, and returns the signed Order Acknowledgement to Landmark.

1. <u>PRICES</u>: All prices for Goods, including, but not limited to, those specified in Landmark's price list or schedule, website or written quotation, are subject to change without notice. Such prices shall be automatically adjusted to reflect Landmark's prices of Products as in effect at the time of the requested shipment date, and each shipment will be invoiced at such adjusted prices. Unless otherwise expressly agreed by Landmark in writing, all prices are EX WORKS (which shall have the same meaning as in the Incorterns 2000 published by the International Chamber of Commerce), exclusived by Bayer.

2. TERMS OF PAYMENT: Unless otherwise expressly agreed by Landmark in writing in Landmark's the Order Acknowledgement, the purchase price for all orders shall be paid in full in advance of shipment.

All payments must be made in U.S. currency. In the event Buyer fails to make any payment when due, Landmark shall have the right, in addition to all other remedies available to Landmark either at law or in equity, to either terminate this Agreement immediately, without notice, or to suspend further performance under this Agreement. Buyer shall be liable for all expenses, including reasonable attorneys' fees, relating to the collection of past due amounts. If any payment owed to Landmark is not paid when due, is hall accrue interest at the rate of the lesser of 15% per annum, or the maximum amount permitted by applicable law, from the date on which such past due amount is due until the past due amount is paid in full. Should Buyer's financial responsibility become unstitutionark, cash payments or security satisfactory to Landmark may be required by Landmark for future deliveries and for the Goods theretofore delivered. If such cash payment or security is not provided, in addition to Landmark's other rights and remedies, Landmark may discontinue deliveries.

3. <u>SHIPMENT AND DELLVERY</u>: a) Unless otherwise expressly agreed in writing by Landmark, shipments are made EX WORKS (which shall have the same meaning as in the Incoterms 2000 published by the International Chamber of Commerce). Responsibility for, and any risk of loss or damage to, the Products shall pass from Landmark to Buyer upon delivery of the Products to carrier. Any claims for shortages or damages must be acknowledged and signed for at the time of delivery. While yaves any claim for damage not acknowledged at the time of delivery. While Landmark will use all reasonable commercial efforts to maintain the delivery date(s) acknowledged or quoted by Landmark, all shipping dates are approximate and not guaranteed. Landmark reserves the right to make partial shipments. Landmark, at its option, shall not be bound to tender delivery of any Goods for which Buyer fans not provided accurate shipping instructions. If the shipping instructions is postponed or delayed by Buyer for any reason including, but not limited to, Buyer providing Landmark with inaccurate shipping instructions, then Buyer agrees to reimburse Landmark for any and all transport and/or storage costs and other additional and incidental expenses resulting therefrom.

b) In instances in which shipment is made FCA or CPT (which shall have the same meaning as in the Incoterns 2000 published by the International Chamber of Commerce) the Buyer is required to provide Landmark with all delivery instructions as well as any special delivery requirements which include, but are not limited to, residential deliveries, lift gate needs, limited access deliveries, lumper service needs. Buyer agrees to reimburse Landmark for any and all additional transport fees Landmark incurs caused by lack of communication of special delivery equirements from the Buyer to Landmark at the time of freight quotation.

c) Please note that our warehouse in Mt. Pleasant loads pallets on trucks sideways in order to maximise floor space on the truck. If, for any reason, Buyer requires the pallets to be loaded front-facing. Buyer is required to request to Landmark, in written form, at the time of Order Acknowledgment confirmation so that Landmark shall not be used as a make sure the warehouse is nade aware of this requirement and in order to avoid further charges due to the Buyer's (or Buyer's customer) inability to unload a truck loaded sideways. Landmark shall not be responsible for any reinhursement in case further charges are caused by the lack of communication of special loading requirements from the Buyer to Landmark at the time of order confirmation.

4. <u>CLAIM ON TRASPORTATION (if applicable)</u>: In instances in which shipment is made FCA or CPT (which shall have the same meaning as in the Incoterms 2000 published by the International Chamber of Commerce) all Products must be inspected at time of arrival for visible damages and Buyer must note on the Proof of Delivery "POD" any damages prior to the delivery driver departing. Failure to note damage on the POD shall result in a waiver of any claim related to damaged Goods. If Buyer discovers concealed damages or shortages after the delivery driver has left Buyer's premises and those damages or shortages have not been clearly specified on the POD, Buyer is required to notify Landmark's Customer Service care department within three (3) days of the delivery in writing by e-mail to customercare@cusa.com, including a thorough explanation as to why the damage could not have been seen at the time of delivery. Buyer's claim must include all of the following information :

- Company name
- Address where the shipment was delivered
- Delivery date
 Name of the carrier
- Order #
- Delivery#
- Description of the damage
- Quantification of the damage (how many boxes, tiles, etc.) Pictures of the damaged material

Upon receipt of the claim, Landmark will initiate a claim with the carrier. Landmark shall not be responsible for any reimbursement or replacement decision made by the carrier under any circumstance. Landmark cannot assure that the claim will be approved by the carrier. Damaged material subject to any claim should not be returned to Landmark's written prior approval and it should not be disposed of or further altered in anyway. Any allegedly damaged Goods should be clearly marked as nonconforming and stored safely until the claim is fully resolved. In the event the claim is denied by the carrier, Landmark reserves the right to also deny the claim and request payment of the corresponding invoice without deductions. Landmark is under no obligation to replace Goods are result of the carrier.

5. LIMITED WARRANTY: a) Subject to the limitations set forth in Section 6 below, Landmark warrants that Products sold by Landmark as "first choice goods" are manufactured in accordance with Landmark's published technical standards. This limited warranty is valid only: (i) for a period of one hundred and eight (180) days from the date of shipment of the Goods by Landmark, or (ii) for the period from the date of shipment of the Goods by Landmark, and (ii) for a second by Landmark are standards. This limited warranty applies only to "first choice goods" sold by Landmark, all GOODS SOLD BY LANDMARK OTHER THAN "FIRST CHOICE PRODUCTS" ARE SOLD AS IS. THIS IS THE SOLE AND EXCLUSIVE WARRANTY GIVEN BY LANDMARK WITH RESPECT TO THE GOODS AND IS IN LIEU OF AND EXCLUDES ALL OTHER WARRANTIES, EXPRESSED OR IMPLIED, ANDISING BY OPERATION OF LAW OR OTHERWISE, INCLUDING WITHOUT LIMITATION, MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE WHETHER OR NOT THE PURPOSE OR USE HAS BEEN DISCLOSED TO LANDMARK, AND WHETHER OR NOT LANDMARK SPROBUCTS ARE SOLD AS LANDMARK FOR BUYERS (OR ANY SUBSEQUENT TRANSFERE'S, AS DEFINED BELOW) USE OR PURPOSE.

b) OTHER THAN REPRESENTATIONS OR WARRANTIES MADE BY LANDMARK IN ITS LITERATURE AND/OR PACKAGING, NO REPRESENTATION OR WARRANTY OF ANY KIND REGARDING THE PRODUCTS MADE BY ANY PERSON OR ENTITY INCLUDING, BUT NOT LIMITED TO, INDEPENDENT DISTRIBUTORS AND SALES REPRESENTATIVES, SHALL BE BINDING UPON LANDMARK.

c) IF YOU ARE A CONSUMER, AND SHOULD ANY APPLICABLE LAW PROHIBIT THE DISCLAIMER OF IMPLIED WARRANTIES SET FORTH ABOVE, THEN ANY IMPLIED WARRANTIES FOUND TO EXIST WILL BE STRICTLY LIMITED TO THE DURATION OF THE LIMITED WARRANTY SET FORTH ABOVE.

d) Notwithstanding the foregoing, this limited warranty does not extend to any losses or damages due to misuse, accident, abuse, neglect, normal wear and tear, negligence (other than Landmark's), unauthorized modification or alteration, use beyond rate capacity, or improper installation, maintenance or application. To the extent that Buyer and/or its agents have supplied specifications, information, representation of operating conditions, or other data to Landmark or Manufacturer in the selection or design of the Goods and the preparation of Landmark's quotation, and in the event that actual operating conditions or other conditions differ from those represented by Buyer, any warranties or other provisions contained herein which are affected by such conditions shall be null and void.

e) Buyer must notify Landmark of any defects in the Products in writing, via certified mail to Landmark Ceramics, at 1427, N Main Street, Mt. Pleasant – TN, 38474, within thirty (30) days of Buyer's receipt of the Goods. Eailure to provide such notice within 30 days of receipt shall act as a complete bar to any claims against Landmark for any defect. Upon receiving Buyer's notice of defect, Landmark shall, at its option, repair, correct or replace the Goods EX WORKS (which shall have the same meaning as in the Incorterns 2000) published by the International Chamber of Commerce), or refund the purchase price for that portion of the Products found by Landmark to be defective. Goods repaired or replaced during the warranty period shall be covered by the foregoing warranty for the remainder of the original warranty period as from the date of shipment, whichever is longer. Notwithstanding the provisions contained in the preceding sentences of this paragraph, Buyer's hall be deemed to have accepted the Products and absolutely and unconditionally waived its rights to claim for any defects: (i) upon installation or attempted installation or attempted installation or alterneted in any way. It is Buyer's obligation to fully inspect the Goods

BUYER HEREBY COVENANTS AND AGREES THAT, SHOULD IT FAIL TO COMPLY WITH THE PROVISIONS OF THIS PRARAGRAPH, BUYER SHALL DEFERD, INDEMNIFY, AND HOLD LANDMARK, ITS OFFICERS, EMPLOYEES, AND AGRENT STOM AND AGAINST ANY AND ALL LIABUITY, LOSS, EXPENSE (INCLUDING REASONABLE ATTORNEYS') FEES), OR CLAIMS FOR INJURY OR DAMAGES (INCLUDING, BUT NOT LIMITED TO GENERAL, CONSEQUENTIAL, INCIDENTAL AND PUNITIVE DAMAGES) ARISING OUT OF OR IN CONNECTION WITH BUYER'S OR BUYER'S EMPLOYEES', AGENTS', REPRESENTATIVES' AND/OR INDEPENDENT CONTRACTORS' BREACH OF THESE TERMS AND CONDITIONS OF SALE. 6. <u>LIMITATION OF REMEDY AND LIABILITY</u>: a) THE SOLE AND EXCLUSIVE REMEDY FOR BREACH OF ANY WARRANTY HEREUNDER SHALL BE LIMITED TO REPAIR, CORRECTION OR REPLACEMENT, OR REFUND OF THE PURCHASE PRICE IN ACCORDANCE WITH SECTION 5 ABOVE.

c) It is expressly understood that any technical advice furnished by Landmark or Manufacturer with respect to the use of the Goods is given without charge, and Landmark and Manufacturer assume no obligation or liability whatsoever for the advice given, or results obtained, all such advice being given and accepted at Buyer's own risk.

7. EXCUSE OF PERFORMANCE: Neither Landmark nor Manufacturer shall be liable for delays in performance or for non-performance due to: acts of God; acts of Buyer; war; fire; flood; weather; sabotage; strikes or labor disputes; civil disturbances or riots; governmental requests, restrictions, allocations, laws, regulations, orders or actions; unavialability of or delays in transportation; pandemic or epidemic; default of suppliers; material fluctuations in the exchange rate between the U.S. Dollar and Euro; or unforeseen circumstances or any events or causes beyond Landmark's or Manufacturer's reasonable control. Deliveries or other performance maybe suspended for an appropriate period of time or canceled by Landmark upon notice to Buyer in the event of any of the foregoing, but the balance of the Agreement shall otherwise remain unaffected as a result of the foregoing.

If Landmark determines that its ability to supply the total demand for the Goods, or to obtain material used directly or indirectly in the manufacture of the Goods, is hindered, limited or made impracticable due to causes set forth in the preceding paragraph, Landmark may allocate its available supply of the Goods or such material (without obligation to acquire other supplies of any such Goods or material) among its purchasers on such basis as Landmark determines to be equitable without liability for any failure of performance which may result therefrom.

8. <u>CANCELLATION</u>: Buyer may cancel orders as follows: (1) For "Made On Order Products" (which means declared as "Made on Order" according current pricelist) and for "Custom Products" (which means Products manufactured upon request of the Buyer, not included in the current Landmark's pricelist), by giving written notice of cancellation 15 calendar days before production of the custom-made Product; (1) For "Made On Order "According on the current Landmark's pricelist), by giving written notice of cancellation 15 calendar days before production of the custom-made Product; (1) For "Made On Order "Accellations will be subject to a 10% cancellation for the total order amount. Additional charges may apply, which include, among other things, all costs and expenses incurred to cover commitments made by Landmark.'s determination of such cancellation charges shall be conclusive.

For Made on Order or Custom Products any cancellation made outside the specified cancellation period explained above will result in the Buyer being obligated to to pay Landmark the full due amount listed in the Order Acknowledgment.

9. CHANGES OR ADDITIONS TO ORDER: Buyer may request changes or additions to the Goods consistent with Landmark's specifications and criteria. Landmark is not obligated, however, to accept any changes or additions. In the event such changes or additions are accepted by Landmark, Landmark may revise the price and dates of delivery accordingly. Landmark reserves the right to make technical and manufacturing changes to the Product(s), none of which will substantially alter the aesthetic of the Product(s), without prior notice to Buyer, except with respect to Product(s) being made-to-order for Buyer.

10. <u>RETURNED GOODS</u>: Except as otherwise provided in paragraph d) of Section 5 above with respect to warranty defects, any and all material which Buyer desires to return and which Landmark agrees to take back will be accepted only with prior written authorization and must be in full compliance of this return policy. Landmark is under no obligation to accept a return, and returns will be accepted in its sole discretion. No returns will be accepted for discontinued material and for products other than first choice products. Returns will not be accepted unless Landmark has first issued a Return Authorization Number. Only Landmark's Customer Service Department can authorize a return, and all return authorizations must be in writing. No sales representative may accept the return of any products without such writen authorization. Products may be returned to Landmark only after inspection by Landmark and after receipt by the Buyer of shipping instructions. Returns will be charged a minimum of 25% restoching fee (unless Landmark erred in filling in writen.) and will be limited to full and unopened cartons that have not been damaged or mutilated in any way. Shipping, handling, insurance, taxes, risk of loss and tariff charges for return products shall be borne by the Buyer.

11. INDEMNIFICATION: Buyer hereby covenants and agrees to defend, indemnify and hold harmless Landmark, its officers, directors, employees, agents, advisers, representatives and affiliates (collectively, the "Indemnitees") from and against, and pay or reimburse the Indemnites for any and all claims, liabilities, obligations, losses, fines, costs, royalties, proceedings, deficiencies or damages (whether absolute, accrued, conditional or otherwise and whether or not resulting from third party claims), including outof-pocket expenses and reasonable attorneys' and accountants' fees incurred in the investigation or defense of any of the same or in asserting any of their respective rights hereunder (collectively, "Losses"), resulting from or arising out of: (i) Buyer's antiago of any provision or ovenant set forth in this Agreement, and/or (ii) Buyer's national or any third party regarding the Goods other than the limited warranty set forth in Section 5 above. This Section is intended to supersed any state law requiring Landmark to indemnify Buyer for any claims made by a Subsequent Transferee, consistent with Section 6, above.3

12. ASSIGNMENT: Buyer shall not assign its rights or delegate its duties hereunder or any interest herein without the prior written consent of Landmark, and any such assignment, without such consent, shall be void.

13. GENERAL PROVISIONS: No change, modification, rescission, discharge, abandonment, or waiver of these Terms and Conditions of Sale shall be binding upon Landmark or Manufacturer unless made in writing and signed on its behalf by a duly authorized representative of Landmark or Manufacturer. No conditions, usage of trade, course of dealing or performance, understanding or agreement purporting to modify, vary, explain, or supplement these Terms and Conditions of Sale shall be binding unless in writing and signed by the party to be bound, and no modification or additional terms shall be applicable to this Agreement by Lundmark's receipt, acknowledgment, or acceptia, edited section, acknowledgment or acceptiance of purchase orders, shipping instruction forms, or other documentation containing terms at variance with or in addition to those set forth herein. No waiver by either party with respect to any breach or default or of any right or remedy, unless such waiver be expressed in writing and signed by the party to be bound. All typographical or clerical errors made by Landmark's receipt acknowledgment, or accepting the constitute a continuing waiver of any other right or remedy, unless such waiver be expressed in writing and signed by the party to be bound. All typographical or clerical errors made by Landmark in any quotation, acknowledgment or publication are subject to correction.

14. SEVERABILITY: If any provision of this Agreement shall be held invalid or unenforceable by competent authority, such provision shall be construed so as to be limited or reduced to be enforceable to the maximum extent compatible with the law as it shall then appear. The total invalidity or unenforceability of any particular provision of this Agreement shall not affect the other provisions hereof and this Agreement shall be construed in all respects as if such invalid or unenforceable provision were omitted.

15. <u>GOVERNING LAW AND JURISDICTION</u>: This Agreement shall be governed by and construed in accordance with the laws of the State of Tennessee without reference to its conflicts of laws principles. Buyer, Landmark and Manufacturer, and any Subsequent Transferee agree to submit all disputes arising out of or in connection with this Agreement to the exclusive jurisdiction of the State and Federal courts of the State of Tennessee, located in Davidson County. EACH PARTY TO THIS AGREEMENT ACKNOWLEDGES AND AGREES THAT TANY CONTROVERSY WHICH MAY ARISE UNDER THIS AGREEMENT IS LIKELY TO INVOLVE COMPLICATED AND DIFFICULT ISSUES, AND, THEREFORE, EACH SUCH PARTY MAY HAVE TO A TRIAL BY JURY IN RESPECT OF ANY LITIGATION DIRECTLY OR INDIRECTLY ARISING OUT OF OR RELATING TO THIS AGREEMENT, OR THE BREACH, TERMINATION OR VALIDITY OF THIS AGREEMENT, OR THE TRANSACTIONS CONTEMPLATED BY THIS AGREEMENT. After any thin set installation of porcelain tile and pavers over concrete, best practices require to perform, after grouting, a first acid deep cleaning.

Alternatively, you can also see paragraph A. B and C here under. Failing to follow these instructions could lead to maintenance issues, most of the times derived from grout residues left on the surface of the tiles/pavers which create a film on the tiles/pavers surface itself that tends to retain dirt. If that occurs, the only way to possibly solve the issue is to perform a deep floor cleaning, using acid-based cleaners specific for porcelain and following a specific cleaning procedure described here under (See paragraph D). Please note that from time to time, depending on the type (cement-based vs epoxy), quantity and aging of the grout residue left on the tile/pavers surface, it could be really hard or even impossible to fully recover from the problem. That is why Landmark Ceramics highly suggests a first acid deep cleaning right after installing and grouting the tile/pavers.

A) First floor deep cleaning after installation

After Grouting the Joints (pic. 1) It is important to remove the excess grout with a sponge and clear water (pic. 2). After 12/48 hours, the grout in the joints will have "set up" / hardened significantly. There will be a noticeable residual "haze". Typically, a diluted acid cleaner specifically for removing "Grout Haze", combined with a soft scrubbing pad will remove the majority if not all the "Haze".

Change your acid/water solution frequently for best results. It is also recommended to keep a bucket of clean water to remove the acid/water solution. It is recommended to keep and use clean dry towels to help remove as much residual water and keep the floor a dry as possible. Please refer to the cleaning chemical company's suggested methods and dilution rates. (pic. 3).

For areas with excess grout or grout that becomes adhered to the face of the tile, further cleaning with an Acid/ Water Solution may be necessary. Please refer to the Cleaning Chemical Company's instructions as not all acids or chemicals are the same. The excess grout residue (pic, 4-5) must be removed so that it does not dry and stick on the surface. It is necessary to change the cleaning water frequently and rinse well. Care must be taken on inlayed, polished and especially Anti Slip products similar to Frontier20. The use of a floor-washing machine combined with the use of a diluted acid detergent helps reach the spaces between adjacent tiles and clean them properly. If such a cleaning procedure is not carried out, or if such cleaning is carried out too late, the grout residue creates an absorbent film, which holds dirt, making the surface difficult to clean: in this case, Landmark Ceramics will not be liable for any damage caused to the surface

B) Day to Day Cleaning

After the post-laying cleaning operation has been thoroughly carried out, as far day to day cleaning we strongly advise against the use of waxes, oily soaps, impregnating products and various treatments (water and oil repellent) on the porcelain stoneware product, as their application is unnecessary. As is often the case in certain off the shelf detergents, they contain waxes and gloss inducing additives which, after various washes, can deposit a bright coat on the floor. Sometimes, even one drop of foods such as Coca Cola, water, wine etc. ...) is sufficient to eliminate this coat, restoring the tile's original appearance, a stain effect is produced in certain zones. In these cases, the floor must be de-waxed, using products to de-wax the applied waxes, following the producer's instructions. For films left by soap, lime scale, dirt, use an acid detergent, suitably diluted in water (read the product instructions carefully).

It is also important to point out that Hydrofluoric acid (HF) and its derivatives can irredeemably damage porcelain stoneware.

For routine cleaning. Landmark recommends the use of bleach or ammonia, suitably diluted in water; for polished porcelain stoneware, dry the floor after washing to prevent unsightly smudges.

TIP: Since rinsing well with plenty of clean water is a fundamental part of the day to day cleaning procedure, Landmark advises against the use of products which state that they "do not need rinsing"

C) Extraordinary Cleaning

In the case of particular and/or particularly stubborn stains, we recommend using specific detergents as those indicated in chart here under reported. It should furthermore not be forgotten that the removal of any type of stain is easier when the stain is still fresh. It is always important to test the detergents on a small area before applying to the entire surface, particularly in the case of porcelain stoneware with a lapped or polished finish.

D) Floor deep cleaning reccomandations to be used in case of grout residues left on tile/pavers surface

1. Preliminary Cleaning Procedure: To begin with, it is important to clean the floor with a traditional detergent (Some examples of suitable detergents you can consider are Deterdek from Fila, Keranet from Mapei) and rinse thoroughly in order to remove any dirt that is present on the tile/pavers aside from the grout left on them. This should be done carefully by following these steps i.Clean the floor with water to remove dust and residues

ii. Apply an abundant quantity of detergent (such as the one pictured below) to clean the floor, following instructions provided on the detergent's bottle and making sure that, during the entire cleaning process, the detergent does not get in contact with grass or water of nearby swimming pools (if any)

iii. Brush strongly to remove the dirt (using a scotch-brite, ideally a motor-brush with scotch brite for big surfaces)

iv. Rinse well with running water (it is recommend to use a vacuum cleaner to avoid burning the grass)

v. Once well rinsed, dry the surface

2. Acidic Cleaning Procedure: Perform the acid cleaning procedure as indicated in the guide provided in the link above, hereunder summarized:

i. Apply a professional acidic cleaner for grout haze on the floor. Some examples of suitable acidic cleaners you can consider are DETERDEK from Fila, KERANET from Mapei, or professional acidic cleaners like the one pictured below:

ii. Apply an abundant quantity of acidic cleaner on the entire floor, following instructions provided on the cleaner's bottle (for a better result, do not dilute with water), and making sure that, during the entire cleaning process, the cleaner (since it is an acidbased cleaner) does not get in contact with grass or water of nearby swimming pools (if any) iii. Once applied, leave the product on the floor for about 20-30 minutes.

in: Bruck strong mechanical action (tile by tile) on the floor while brushing. Please note that cleaning without a strong mechanical action (tile by tile) on the floor while brushing. Please note that cleaning without a strong mechanical action (e.g. cleaning using a simple mop) is going to be useless and ineffective.

vi. Repeat everything from point "2.i" as many times as necessary to achieve the desired result vii. Dry the floor's surface

E) Additional Notes & Reccomandations

Please note that if the grouting was done well before the time of attempted cleaning, the grout residue left on the tile surface would have had time to settle and mature. In this case:
 It is particularly important, during the acid cleaning process, to let the acid settle in on the floor for a few minutes before brushing, so that the acid can soften the grout.
 It is also crucial to brush the tiles using the right tools and to apply on the floor a strong and prolonged mechanical action (tile by tile).

• It is very likely that a single deep acid cleaning will not be sufficient. In this case, it will be necessary to repeat the operation several times in order to eliminate all the grout residues. Keep in mind that the grout residue might not be immediately visible when the floor is clean, but can only be seen when the grout gets dirty. Therefore, even if the floor may appear clean after the first deep cleaning process, it could still have grout residue left on the surface of tile/pavers, that will get visible once they'll get dirty again. If that is the case, it will be necessary to repeat the deep cleaning procedure more than once unit reaching a satisfactory result. 2. While performing the deep cleaning process, please be aware of any surrounding grass (making sure that the acid cleaner does not get in contact with it) 3. In case a deep cleaning is needed around a pool, make sure that during the entire cleaning process the acid cleaner does not get in contact with the water of the swimming pool

A Never use sealers of any kind to the porcelain tiles and parts. Scalers are unnecessary and, furthermore, sealing will change the D.C.O.F. (Dynamic Co-efficient of Friction) of the pavers, resulting in a surface that will become more slippery. Furthermore, since Porcelain has such a low absorption rate, the sealer will unlikely stick and will most likely come off over time. 5.Bright colored products, in particular white and extra-white tiles, are very delicate and, although for all intent and purpose are hygienically clean, However, they can get dirty more easily than darker tiles. It is therefore necessary to remember that these particular products require careful regular maintenance.

Warnings

The above suggestions are a result of research, laboratory tests and several years' experience. However, the cleaning features of the materials may vary significantly according to the different installation methods, conditions of use, types of surface and destination. 20. PORCELAIN PAVERS: ADDITIONAL RECOMMENDATIONS FOR THE INSTALLATION, ORDINARY CLEANING AND MAINTENANCE.

Landmark Ceramics recommends carrying out the procedures for the ordinary cleaning of Frontier20 floor surfaces using water and commercially available neutral detergents: the inclination of the surface and the space between adjacent slabs for dry-system installation favor the natural flow of water. However, it is important to take into consideration that any type of floor surface is subject to the surface tension effect of liquids: it is the same property of water that gives the tendency to transform into spherical droplets and which cause the curved top surface of a glass full of water. The surface tension can obstacle the complete drainage of water and cause a temporary stagnation of liquid on the slab edges. In order to avoid this problem, Landmark Ceramics recommends ensuring adequate inclination of the surface during installation so as to encourage the flow of water between adjacent slabs. Please remember in any case that, in view of the distinctive advantages of porcelain stoneware, Frontier20 absorbs practically no water, which makes it highly frost-proof. This may lead to localized water pooling, mainly on the edges of the pavers, independently of the manner and quality of the laying. Laying is also recommended with a minimum gap of 4 mm (5/32"). Should liquid deposit on the surface, it is recommended to push it towards grout lines using a brush or remove it with a wet and dry vacuum cleaner.

Specific details and instructions are given for each of the following installation options. Different climates and geographical locations will affect the thickness of the base. Depending on the location, contractors will lay the standard base thickness to install porcelain pavers for the needs of the area. When installing porcelain pavers, the bedding course sand must be pre-compacted and then struck off with a screed to the required thickness as shown in the drawings. Before the laying of the porcelain pavers, the sand layer underneath must be pre-compacted. The sand layer needs a 5 to 6% moisture content to insure a smooth strike off finish. Compacting dry sand will not give the desired results.

- Only use a paver saw with a wet cut porcelain blade to wet cut porcelain pavers.
- Before installing your porcelain pavers in sand set installations, pre-compact and strike off your sand leveling course.
- Plastic 3/16" (4mm) spacers must always be used to install pavers on sand set and permeable installations
- Never install pavers with porcelain to porcelain contact.
- The use of plate compactors is not recommended to be used on the porcelain pavers.

21. PORCELAIN PAVERS JOINT FILLING.

When installing porcelain paver on sand set base, fill the 4 mm (approx. 3/16") paver joints with these options:

Traditional sand- Fill the open joints with traditional drv sand until completely filled. Sweep any excess sand off the payers. Refilling of the joints with sand may be needed in the future due to wind and rain erosion

Polymeric sand-Polymeric sand is a blend of polymers which harden when subjected to moisture. Sweep the sand into the open joints until completely filled. All excess sand and dust must be swept from the surface. Use a blower for the final dust removal to make certain all excess sand is removed. Any residual sand or dust can result in staining of the surface. Once the filling of the joints and the cleaning of the surface is complete, mist the pavement with water which activates the polymer and cures the mixture.

22. PORCELAIN PAVERS HANDLING AND SPECIALTY TOOLS.

Porcelain paver pallets are shipped with a very strong plastic covering and the individual units are packaged in protective cardboard boxes. The protective cardboard boxes guard them from the possibility of chipping. The handling of multiple loose stones can result in damaging or chipping of the pavers. Protect any un-used boxed pavers from the elements once the plastic shipping cover is removed. This insures the integrity of the protective cardboard boxes. Wet cut paver saw is used to cut paver accurately and cleanly to fit around edges and corners. The saw must be equipped with a diamond blade manufactured for wet cutting porcelain and designed to safely cut a 24" (60 cm) length porcelain paver. A paver clamp to easily handle the installation and removal of pavers. Gloves are highly recommended while handling and installing porcelain slabs to protect the hands from injury. Notched trowels and grout float tools for cementitious adhesive and grout Installation. Follow the adhesive and grout manufacturer's recommendations to select the appropriate tools needed for application.

23. PORCELAIN PAVERS RAISED FLOORS INSTALLATION SYSTEMS: WARNINGS.

Landmark products are made using the best technology available, and their technical performances match or exceed requirements from both ASTM and ISO standards for porcelain products.

Nevertheless, if the application of the 20 mm slabs requires the ceramic product used in structural installations (such as, but not limited to, raised floors), the project engineer and/or customer must carefully assess the project requirements with regard to the technical specifications of the slabs

To prevent the risk of damage or injury, the manufacturer recommends:

• With regard to a raised floor installation a ceramic slab may fracture on impact if a heavy object falls on it. Therefore, the manufacturer recommends checking the specific intended use before starting the installation and:

As far as supports requirements, comply with the table for raised installation provided below.

25. COVE BASE AND BULLNOSE SHADE MATCHING WITH FIELD TILES

Regarding the use of Cove base (hereinafter referred to as "CB") and Bullnose (hereinafter referred to as "BN"), it is extremely important to understand the following:

1) CB and BN are special pieces intended for the wall basal use only and are meant to protect the wall from water, chemicals and dirt during the cleaning activities

2) The main difference between BN and CB is that the second one is able to transition from the floor to the wall with a rounded connection edge that allows a better cleaning action in correspondence of the contact point between wall and floor. They both have a rounded miter cut on the upper side and not a straight cut. The rounded corner is meant to be the last ceramic bit before the plain wall (not covered by tiles) begins, and it is rounded for both esthetic reasons and easier cleaning.

o BN and CB are installed vertically, million tance of the tile used on the floor and hence due to the different refraction of the light their tones will appear different anyways. Consequently, it has no relevance if the tone of the tile used on the floor and the tone of the BN and CB can be combined or not. Once installed, they will look as two different tones.

o The CB is made with different equipment and raw materials from the field tiles so that the shades are even more unlikely to match. The BN may have an easier combination as it is cut down directly from the field tile, but being used vertically the light refraction will still make them appear different.

4) Both the CB and BN are not designed to joint together ceramic covered floors and walls, and that is why the upper side is rounded and not straight. Landmark Ceramics recommends NOT to use the CB nor BN, wherever a ceramic covered wall is needed above them.

5 For the above said reasons Landmark cannot be held responsible for problems related to the tone mismatching between the aforementioned BC and CB and the relative field tiles, for which an improper use becomes evident.
